**Rules and Regulations**

1. Entrant must compete in the correct age group as of the first day of the national pageant.
2. Mrs. Entrant must be married as of the date of entry, and must remain married throughout her reign. All other titles/queens must be single and without children for the duration of the reign.
3. Entrant must sign a full contract and adhere to the rules and regulations completely.
4. Entrant must be a US Citizen. (residence at a military installation is acceptable)
5. Entrant may not hold another Regional, State or National Pageant title as of the crowning/competition date of the state or national pageant. Miss Teen, Miss and Mrs. title holders may not compete in another pageant while holding the title. However, Miss Teen State and Regional Titles may compete in their High School Pageants. All of the junior titles must have prior approval before competing in all pageants such as fundraiser, festival or school pageants.
6. Entrant must provide all documents, completed paperwork and photographs and entry fee balance as outlined in the General Information by the deadline.
7. Entrants must submit the completed application and non-refundable \$150.00 deposit to begin the application acceptance process.
8. Entrants may compete in the State Pageant as many times as she wishes: however, previous State winners may not compete as that same State title in the same age division again.
9. The State winner/queen will represent her state and attend National Pageant.
10. Entrants must be, and continue to be of good moral character, has not committed crimes resulting in imprisonment, and has not appeared nude or provocative in photographs, films or publications.
11. Judges can/will look at social media post. We want you to promote your community service, your title and the system.
12. Entrants should be on time. If you are tardy, points can/will be deducted unless prior approval is given.
13. The State winner will be bound to the rules and regulations stated or implied as outlined by the Contestant Agreement as provided by The Miss All-Star United States, LLC.
14. Entrants will conduct themselves in a manner that reflects professionalism towards themselves, the State and National Pageant, State Pageant Director, other entrants, and the State prior to, during and throughout her reign as a Local Delegate or State Winner.
15. The Miss All-Star United States, LLC reserves the right to disqualify applicants, prior to the Pageant without reimbursement of fees paid.
16. All deposits, fees or advertisement sales are non-refundable for any reason.
17. Entrants failing to comply with the implied, mentioned and /or understood Rules and Regulations will result in disqualification.
18. Please note the word State can also be substituted for Regional title. Once the title is awarded you fully agree to compete in the national Miss All-Star United States Organization Pageant, LLC. Entrants agree to all rules and regulations written, applied and understood.
